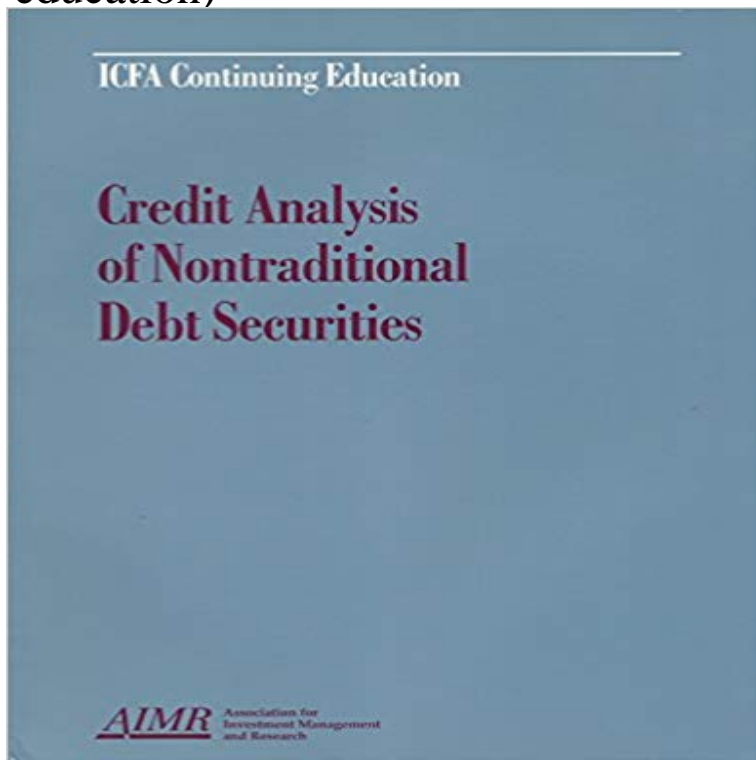


Credit Analysis of Nontraditional Debt Securities (ICFA continuing education)
